The prices for the equipment and services are subject to our Standard Terms and Conditions of Sale, which if not included as an attachment of this proposal, are available on request from G J Walker Air Handling Systems Pty Ltd and from the webpage <u>www.gjwalker.com.au</u> Due to continuing changes in exchange rates and government legislation affecting such things as sales tax and duty we recommend that you review these terms and conditions.

All prices quoted do not include sales tax, unless specifically stated otherwise. If applicable, the final product value is subject to GST at the rate of 10% (subject to change).

INCLUSIONS AND EXCLUSIONS

The equipment and services have been described in the proposal and the attached technical schedules. We ask you to pay particular attention to any inclusions or exclusions that might be mentioned.

PRICE VALIDITY

The prices for equipment and services are fixed if we receive, within 60 days of the date of the quotation, an acceptable order to G J Walker Air Handling Systems Pty Ltd, which allows us to produce and ship the equipment as per the relevant standard delivery cycle.

WARRANTY -PARTS

As per our Standard Terms and Conditions, the equipment is warranted for parts only for a period of 18 months from shipment, or 12 months from start-up, whichever period expires first. If you require a delayed or extended warranty we will be pleased to give you a proposal for this upon request.

WARRANTY-LABOUR

Warranty labour is available at an additional price provided it is ordered together with the equipment. If not already quoted we will be pleased to give you a proposal upon request. Note that for projects located more than 50 km from Australian capital cities travel time and accommodation expenses will be charged separately. All labour rates quoted are based on our standard labour rates for work between 8.00am and 4.30pm, Monday to Friday, and do not include for any site allowances or special conditions.

Adequate product access to service for warranty and future general service is a requirement of install, GJW will not be liable for charges where access is limited and additional works to gain access for warranty or service is required. GJW will advise on access requirements if installer is unsure.

COMMISSIONING & ASSEMBLY ASSISTANCE

Commissioning Assistance and/or assembly assistance, if included, or quoted as a price-add, is based on labour rates for work between 8.00am and 4.30pm, Monday to Friday and does not include for any site allowances or special conditions.

Commissioning Assistance is limited to providing supervision services in equipment set up, safe and reliable start up procedures and confirmation of operating limits and parameters. Clients are required to have on site their own licensed and qualified refrigeration mechanic(s) and if required electrician(s).

This service is limited to equipment supplied by G J Walker Air Handling Systems and specifically does not include ancillaries like BMS, remote control systems or any other sub-systems.

Unit sectional supply is often unavoidable and simple joining system hardware and sealing tape is supplied when unit splitting is employed, joining of sections is a site requirement and not completed by GJW unless specified and agreed in writing.
